Case study 1: Employment dispute

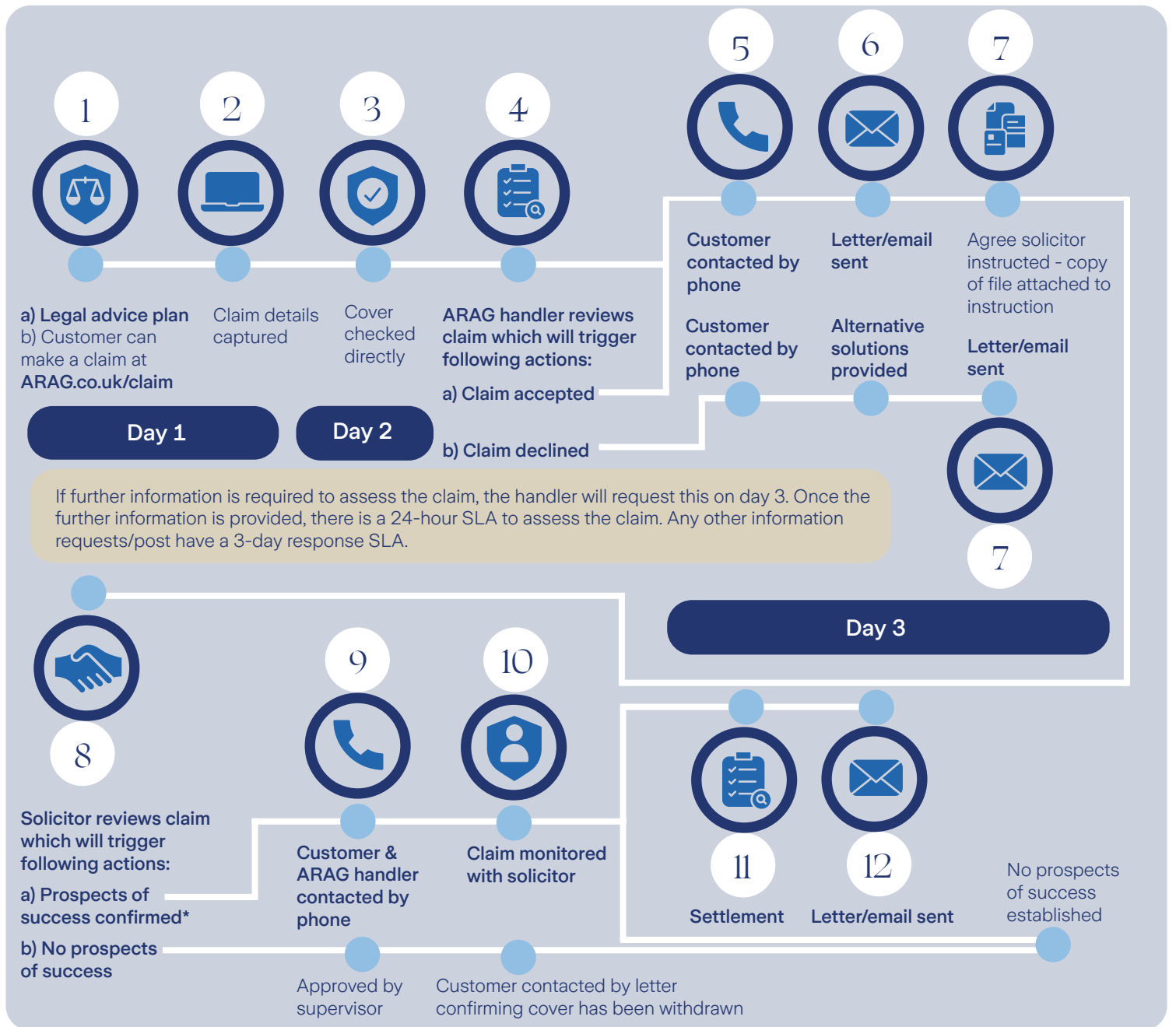
