

Excess Employers' Liability

Summary of cover



This leaflet provides a summary of the significant features, benefits and limitations of the cover provided by the Zurich Insurance Company Ltd Excess Employers' Liability policy. The full terms, conditions and exclusions are shown in the policy document. If you want to see full details of the cover, please refer to the policy document.

Type of insurance and cover

This policy provides top-up cover in excess of that provided by the primary insurer. The terms, conditions and exclusions are those contained in the primary insurer's policy wording.

The duration of this non-investment insurance contract is 12 months.

Significant features and benefits

- Top-up cover that sits in excess of that provided by the primary insurer's policy.

Significant and unusual exclusions or limitations

- Asbestos
- Data protection
- Inner limits of indemnity
- Terrorism
- Work offshore

and any limitations/exclusions that will be found in the primary insurer's policy.

Insurance Act 2015

This policy is compliant with the principles of the Insurance Act 2015 law reforms. It also incorporates an 'opt out' which aims to promote good customer outcomes. We have opted-out of the 'proportionate reduction of claim remedy' available to insurers under the Act. This means that in cases of non-disclosure or misrepresentation which are neither deliberate nor reckless, if we would have charged an additional premium had we known the relevant facts, we will charge that premium and pay any claims in full rather than reducing claims payments in proportion to the amount of premium that would have been charged.

The remedy of charging additional premium will apply only if you make a presentation of risk to us specific to the excess of loss policy which is separate from that made to the primary insurer. In respect of the presentation of risk you make to the primary insurer or to the primary insurer and us jointly the remedies available under the primary policy will apply.

We believe that our 'additional premium approach' should, in most situations, be more favourable to our customers when compared to the proportionate reduction of claim remedy. Our additional premium approach does not affect our right to apply the other remedies available under the Act for non-disclosure or misrepresentation.

Cancellation rights

This policy does not entitle you to a cooling-off period.

Our complaints procedure

If you are not happy with the outcome of your complaint, you may be able to ask the Financial Ombudsman Service to review your case.

We will let you know if we believe the ombudsman service can consider your complaint when we provide you with our decision. The service they provide is free and impartial, but you would need to contact them within 6 months of the date of our decision.
