Premises must be self-contained and of standard construction.

The maximum sum insured for any one premise is £10 million (Property & Business Interruption). We are happy to cover multiple premises.

Policyholders must be based in the UK, Channel Islands or Isle of Man.

Properties must be located in the UK, Channel Islands or Isle of Man.



Core cover

- Our property covers are average free.
- Material damage on an 'all risks' basis including subsidence.
- If refrigerated contents cover has been selected, we will provide cover for deterioration of refrigerated contents (including vaccines) for up to £2,500 per fridge/freezer and up to £20,000 in total.
- Increased cost of working cover £50,000 with a 24-month indemnity period, with an option to increase this limit or opt for a full Loss of Revenue/Income cover.
- Money – £7,500 during business hours with an option to increase to £15,000.
- Public and products liability – £2 million limit as standard with options to increase to £5 million or £10 million.
- Data Protection Act extension with a £1 million limit.
- Employers' liability – £10 million limit.

Optional covers

- Specified items 'all risks' – Available up to £40,000 with option to select EU or worldwide cover.
- Computer breakdown – up to £250,000 limit.
- Legal expenses – £100,000 or £250,000 limit available (provided by ARAG).
