## Small Fleet

Our Small Fleet policy is designed for businesses with a fleet of between 2 and 20 vehicles.

### **Appetite**

- Fleets between 2 and 20 vehicles
- Predominantly commercial cars, or mixed vehicle schedules
- At least 1 year confirmed claims experience, either fleet CCE or No Claim Discount (NCD)



### Core cover

Any driver cover.

No young/inexperienced driver excesses.

Uninsured loss recovery service, including motor prosecution defence cover.

Automatic Europe-wide (EU and Associated countries).

Courtesy vehicle if the insured vehicle is being repaired following an accident, fire or theft (subject to availability).

Theft or loss of keys, to replace keys, lock transmitter and locks.

Medical expenses for each person travelling in the vehicle where injury has a direct connection with the insured's vehicle.

Cover for damage to or loss of personal effects.

New for old vehicle replacement on commercial car and commercial vehicle (conditions apply).

The cost of this additional cover is included as part of the premium charged upon purchase of the policy.
