

Professional Indemnity for General Professions (Negligence basis)

Summary of cover



This document outlines the key features, benefits and limitations of the cover provided by the Zurich Insurance Company Ltd Professional Indemnity policy for General Professions. If you want to see the full terms, conditions and exclusions, please refer to the policy document.



Type of insurance and cover

This policy provides breach of professional duty cover for incorrect professional advice or services provided by professional firms.

The standard duration of this non-investment insurance contract is 12 months.



Significant features and benefits

- Limits of indemnity up to £5 million.
- Cover for a wide variety of professions.
- Liability arising out of the provision of professional services.
- Libel or slander.
- Breach of confidentiality.
- Unintentional breach of copyright.
- The consequence of any loss of or damage to business records.
- Dishonesty of employees provides cover for claims made against you arising from dishonest, fraudulent, criminal or malicious acts by your employees.
- Cover for costs of representation at any official examination or enquiry into your affairs.
- Loss of documents covers expenses incurred in replacing or restoring lost or damaged records associated with your services or for which you are responsible.
- Cover for outstanding fees in the event that a pursuance of those fees may result in a counter claim for a greater amount.



Significant and unusual exclusions or limitations

- Known defamatory statements or publications.
- Claims brought within the United States of America or Canada.
- Work done prior to the retroactive date.
- Pollution or contamination.
- Prior circumstances and claims.
- War, terrorism or asbestos related events.



Insurance Act 2015

This policy is compliant with the principles of the Insurance Act 2015 law reforms. It also incorporates an 'opt out' which aims to promote good customer outcomes. We have opted-out of the 'proportionate reduction of claim remedy' available to insurers under the Act. This means that in cases of non-disclosure or misrepresentation which are neither deliberate nor reckless, if we would have charged an additional premium had we known the relevant facts, we will charge that premium and pay any claims in full rather than reducing claims payments in proportion to the amount of premium that would have been charged.

We believe that our 'additional premium approach' should, in most situations, be more favourable to our customers when compared to the proportionate reduction of claim remedy. Our additional premium approach does not affect our right to apply the other remedies available under the Act for non-disclosure or misrepresentation.



Cancellation rights

This policy does not entitle you to a cooling off period.

Our complaints procedure

We will let you know if we believe the ombudsman service can consider your complaint when we provide you with our decision. The service they provide is free and impartial, but you would need to contact them within 6 months of the date of our decision.
