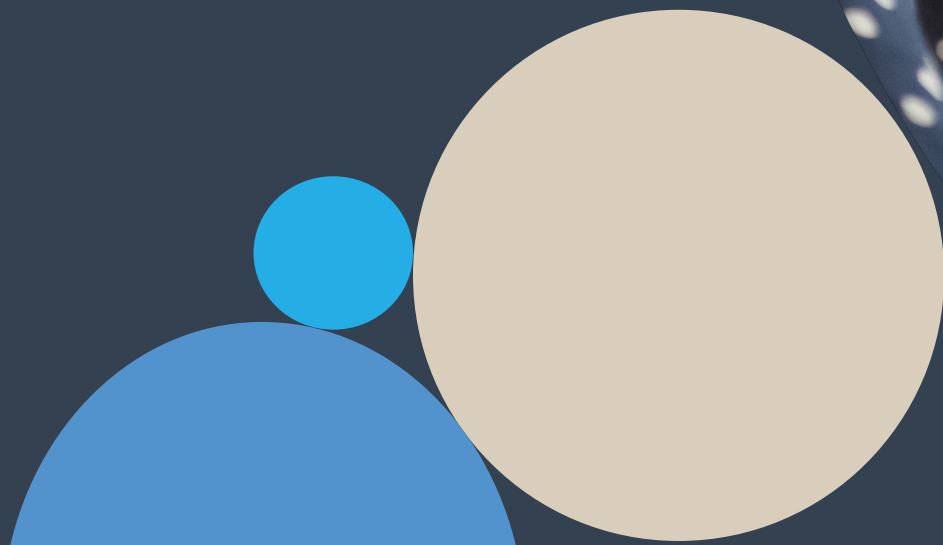

Directors and Officers Liability

Offers financial protection to directors and officers against allegations of wrongdoing in their capacity.

This includes damages, judgements and awards which insured persons become legally liable for, as well as legal costs relating to the allegation and costs and expenses incurred as a result.

In addition, your customer may be reimbursed to the extent it has lawfully indemnified any director or officer.

Corporate Legal Liability

Cover for legal expenses and settlements associated with claims brought against an insured entity alleging wrongful acts by the companies' executives or board members.

These include breaches of fiduciary duty, negligence or mismanagement. It helps protect the organisation and its leadership from financial losses relating to legal actions and investigations.

Covers claims brought by past, current or prospective employees related to actual or alleged employment wrongful acts, including discrimination, harassment, wrongful termination, failure to consult, and unfair dismissal. It helps protect businesses from legal costs associated with these claims.
