Notice of Participation of additional Participating Employers

1. Introduction

This Notice of Participation is made in accordance with Clause 4.1 of the Zurich Registered Group Life Master Trust (the “**Scheme**”) Definitive Trust Deed and Rules dated **22/06/2018**, as amended from time to time, (the “**Definitive Deed**”).

In this Notice terms shall have the meanings given to them in the Definitive Deed.

In the event of any conflict or inconsistency between this Notice and the Definitive Deed, the provisions of the Definitive Deed shall prevail.

2. Admission to the scheme of additional Participating Employers

(the “**Principal Employer**”)

The Principal Employer wishes that this Notice admits the entities listed in the Schedule as additional Participating Employers in the Scheme with effect from _____ or, if later, the date on which this Notice is signed or such date as is agreed in writing between the Principal Employer and the Founder (the “**Participation Date**”).

The Principal Employer and each Participating Employer covenants with the Founder and the Trustee that while it is participating in the Scheme it will observe and perform all the provisions of the Definitive Deed and comply with any applicable laws so far as they relate to it and to its Members (or, where applicable, their survivors).

For the avoidance of doubt, nothing in this Notice shall confer any benefit on Members unless a valid Policy is in place, and the provisions of the Definitive Deed shall prevail over this Notice.

3. Admission of members

On and from the Participation Date, employees of the Participating Employers who satisfy the conditions under Rule 3 of the Definitive Deed shall become members of the Scheme.

4. Payment of premiums

The Participating Employers shall pay all Premiums due in respect of their Members as required by the terms of the Policy, failing which no benefits shall be payable in respect of Members as stated in Rule 1.1 of the Definitive Deed.

5. Whole agreement

This Notice, any previous Notice(s) of Participation completed by the Principal Employer, the Definitive Deed and the Policy represents the entire understanding between the Principal Employer, the Trustee and the Founder and supersedes and replaces all previous agreements between the parties in relation to such subject matter whether oral or in writing. The Principal Employer acknowledges that it did not rely on any statements or representations made by the Trustee or the Founder prior to signing this Notice (or any change to this Notice). Neither the Trustee, nor the Founder shall have any liability for misstatement or misrepresentation unless such untrue statement or representation was made fraudulently.

The Principal Employer confirms it is authorised to complete and sign this Notice of Participation on behalf of the Participating Employers and to bind them accordingly to its terms. This Notice may be signed in any number of counterparts which taken together shall constitute one document.
