Endorsement Number	Description
<b>1. Anti-Theft Protection</b>	Theft cover under Section 4 of the Policy will not apply unless the security device named on the Proposal Form/Statement of Facts or in the Schedule is in use at the time of the loss.
<b>11. No Claim Discount Protection</b>	We will allow our maximum No Claims Discount as long as you have not made more than two claims during the last 5 years in a row (or 3 years if your policy was taken out before 1/10/1999).
<b>31. Vehicles Not Made for the UK</b>	<ul style="list-style-type: none"> <li>• Section 6 of Part A of this Policy (New car replacement) does not apply.</li> <li>• if your car is damaged beyond economical repair or stolen and not recovered we will settle any claim based upon the lesser of what you paid for the car or its market value in the United Kingdom at the time of the loss or damage.</li> <li>• if your car is damaged and suitable parts or accessories are not available in the United Kingdom to repair it we may choose to give you a cash settlement as an alternative to repairing your car.</li> <li>• we will not pay for the cost of importing any part or accessory into the United Kingdom.</li> <li>• following a claim which we have accepted under this policy a courtesy car will only be supplied to you by our Zurich approved repairer when they have all the necessary parts or accessories to fully repair your car.</li> </ul>
<b>43. Garaging</b>	When your vehicle is kept at your home address overnight there will be no cover under Sections 4 and 5 of the Policy for any loss or damage which happens between 10.00pm and 6.00am unless your vehicle is in a locked garage.
<b>44. Kept Overnight</b>	When your vehicle is kept at your home address overnight there will be no cover under Sections 4 and 5 of the Policy for any loss or damage which happens between 10.00pm and 6.00am unless your vehicle is on a driveway or in a garage.
